David E. Baker is Vice President for External Affairs at the Illinois Institute of Technology (IIT), Executive Director of the University Technology Park at IIT, and Chairman of the Heidelberg Club International in Chicago. Mr. Baker was named Vice President for External Affairs in March 1995. He is responsible for the University's governmental relations, technology park development, and trustee relations. Over the past 12 years, he has worked to create the University Technology Park at IIT of which he serves as Executive Director. He managed all university strategic plans from 1993 through 2009. He helped to create the Perspectives Charter Schools/IIT Math & Science Academy and serves on its Board of Directors. Prior to joining the University, Mr. Baker served as President of The Illinois Coalition, whose mission is to strengthen the Illinois economy through science and technology. From 1980 to 1989, Mr.

Baker served as the Executive Vice President of the Illinois State Chamber of Commerce, the state's largest business advocacy organization. Mr. Baker served as the 2012-2013 President of the Association of University Research Parks, and on the boards of Perspectives Charter Schools, the Chicagoland Entrepreneurial Center and Lincoln Park Village. He is a member of the Economic Club of Chicago. Mr. Baker holds an M.A. from Johns Hopkins University School of Advanced International Studies and an A.B. in History with a minor in Economics from Stanford University.



Mark E. Evans was named Senior Vice President and Chief Financial Officer at Siemens Industry, Inc., Building Technologies, in Buffalo Grove, Illinois, in March 2011. This division's annual revenue exceeds \$2.7 billion with more than 8,000 employees in 110 branch offices in Canada, the U.S. and South America. Mr. Evans has broad international and general management experience in all aspects of strategic planning, finance, and accounting, business development and project management in the solutions and manufacturing industries.
